A. Land Acknowledgement Guest Speaker - Ami Admire

Ami Admire is Payómkawichum from the Rincón Indian Reservation. Joseph Morales, Della Kolb, and Marcella Ramos are her grandparents. Her reservation is one of 18 reservations in San Diego County; and Rincón is one band of the original tribal peoples of this land, the Cahuilla, Cupeno, Kumeyaay, and Payómkawichum.

Over the years, Ami's passion for teaching grew and so did her sense of responsibility to her community. As an educator and director of a traveling youth storytelling program on her reservation, she has spent 23 years reducing the impacts of trauma, suicide and substance misuse by connecting youth to their histories, language, and truth; with the ultimate goal being healing for young people and their families. She is a 2019 recipient of the National Indian Health Board's Local Impact Award. In most recent years, she has been advocating for student rights and equity in schools by creating safe spaces for Native and Indigenous youth through the facilitation of Native and Indigenous Clubs and Unity Classes. She is co-founder of the Indian Education Equity Team, a coalition created to show strength and solidarity among our local Indian Education Centers, parents, and organizations. Her coalition is present at school board, parent advisory meetings, and presents workshops to teachers and urban organizations regarding the intricacies and relevance of Southern California's tribal people.

Overview:

Acknowledgment of the traditional Native inhabitants of land is a practice encouraged by various organizations, including the U.S. Department of Arts and Culture. (USDAC is a nonprofit organization, not a federal agency.) The practice is starting to take hold in some U.S., Canadian, New Zealand, and Australian locations. Below are several questions and responses about land acknowledgment.

What is land acknowledgment?

A Land Acknowledgment is a formal statement that recognizes the unique and enduring relationship that exists between Indigenous Peoples and their traditional territories.

Why acknowledge Native inhabitants of a land area?

The USDAC states that acknowledgement is a way of showing respect and correcting the perception that Native peoples are gone from the land or that they have little to offer today's communities.

What about all the other people who lived here--for example, Africans brought to this continent against their will, Latinos who were displaced in areas of North America, Japanese-Americans who lost their homes and businesses during the World War II era, and communities of color that have lost their neighborhoods due to gentrification? Shouldn't we acknowledge them too? The USDAC's guide to honoring Native land responds with this: "(f)or more than five hundred years, Native communities across the Americas have demonstrated resilience and resistance in the face of violent efforts to separate them from their land, culture, and each other. "This approach recognizes the especially long-term nature of Native connection to ancestral land. It does not mean that other groups have not been impacted by people of European descent, but that the roots of Native peoples on this land go far back into prehistory and that EuroAmerican appropriation has been particularly widespread, long-lasting, and significant here. A variation on the above approach is to use the Native Land Acknowledgement on a regular basis but, from time to time, do other things to recognize the losses experienced by other people who have been marginalized or oppressed in our society.
