## School Facility Conditions and Planned Improvements

The District provides services through its Maintenance, Operations, and Services (MOS) Department. Lemon Grove School District (LGSD) continues to pride itself on maintaining quality facilities to provide a safe learning and working environment for its students and staff.

School custodial and district maintenance staff conduct frequent inspections to ensure that all sites are clean, safe, well maintained, and in good repair. We have hired detail-oriented custodial teams that maintain the cleanliness of all classrooms to ensure all COVID deep cleaning protocols and procedures are followed consistently. We have also purchased several 360° machines, so we are able to sanitize high traffic areas throughout the day at regularly scheduled times. The Maintenance Department is in the process of establishing preventative maintenance programs that ensure all schools are managed at an efficient operating level. All classrooms, playground areas, and working spaces for students and staff satisfy the building capacity requirements of the Education Code.

The Lemon Grove School District has always emphasized the importance of a clean, safe environment for learning and working. The environment of each campus is a matter of pride for students, staff, and parents. To ensure that our facilities are in good repair condition, custodians at each site perform monthly inspections, and the district maintenance crews complete their work orders in a timely manner to maintain sustainability.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

## Percentage of Students Meeting or Exceeding the State Standard on CAASPP

The 2020-21 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-21 school year. Therefore, the 2020-21 data between school years for the school, district, state are not an accurate comparison. As such, it is inappropriate to compare results of the 2020-21 school year to other school years.
