The development of the ESSER III Expenditure Plan has been closely connected to the development of the district's Strategic Plan, Local Control Accountability Plan (LCAP) and Expanded Learning Opportunities (ELO) Grant Plan. In the development of these plans the Lemon

Grove School District participated in purposeful engagement of all required stakeholder groups. District meetings were held throughout the 2020-21 school year for the following groups: District English Learner Advisory Council (DELAC), Parent Teacher Advisory Council, LCAP/District Budget Advisory Committee (DBAC), District & Site Administrators, Certificated & Classified Staff, including both bargaining units, and Students. Family engagement meetings were scheduled both during the school day and during the evenings to accommodate parents who might not be available to attend meetings during the traditional workday. To help promote the engagement of families in the decision-making process the District employed a Parent/Family Specialist: Teacher on Special Assignment and a Spanish/English Translator. The methods for gathering input and expanding the discussion included virtual meetings using the Zoom platform, flyers, email, websites, all calls, surveys, social media, and when in-person communication was deemed safe, face-to-face communication.

During the 2020-21 school year, Community Circles were held at each of the seven schools to gather input and feedback from parents regarding their experience with distance learning and the needs of students. In addition, the district held a Black and Pan African Student Excellence Committee meeting where parents and staff provided input on students' experiences including services and supports for students moving forward. Parent surveys were also sent during the 2020-21 school year to gather information from parents/guardians regarding student experience in distance learning and the impact of the COVID-19 pandemic. The District English Learner Advisory Committee (DELAC) members, which includes parents of multilingual students, provided input and feedback at the regularly scheduled DELAC meeting, including the first meeting of the 2021-22 school year held on September 21, 2021. Members of the LCAP/DBAC (Local Control Accountability Plan/District Budget Advisory Committee) also provided input and feedback through the LCAP/DBAC meetings including the first meeting of the 2021-22 school year held on September 27, 2021. In addition, the Professional Development (PD) Committee, which includes teacher and staff representatives, provided feedback on the district's Strategic Plan and the professional learning needs of staff. District Management, including site principals, have also been key in helping to shape priorities. Through scheduled District Leadership Team meetings and constant dialogue, district leadership have provided input and feedback to inform priorities. As we discussed the impact of the pandemic on our students and families, conversations with staff reinforced the priorities identified by our parents & families.

A meeting with the SELPA was also held for review and feedback on the LCAP which was used to inform additional district plans.

#### A description of how the development of the plan was influenced by community input.

The planned actions and expenditures in the ESSER III Expenditure plan were directly influenced by stakeholder input.

Family members specifically requested more parent workshops, additional meetings and family centers at all sites, including expanded hours for parent volunteer coordinators. Additionally, parents asked for expanded opportunities for struggling students to receive additional help during and outside of school hours as well as celebration of diversity and culture including culturally relevant pedagogy and associated professional development for teachers. School staff also requested professional development in culturally responsive pedagogy as well as Restorative Practices. Staff were driven by a commitment to equity for all, with a desire to support students by raising reading levels. Flexible furnishing and welcoming classroom environments were also a priority for staff.

All of the above referenced items were included in the ESSER III Expenditure plan.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;
  - Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
  - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
  - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;

- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

**Note:** A definition of “underserved students” is provided in the Community Engagement section of the instructions.

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
